**Unrevoked Consent to Electronically Distribute Documents, Notices & Disclosures**

*Electronic Delivery Defined. The Davis-Stirling Act defines electronic delivery to mean "email, facsimile, or other electronic means." (Civ. Code §1350.7(b)(3).) Other electronic means include posting on an electronic message board or network which the association has designated for those communications, together with a separate notice to the recipient of the posting. (Corp. Code §20.) If a document is delivered by electronic means, delivery is complete at the time of transmission.*

As a homeowner in the Sunrise Homeowner’s Association (SHA), the Board of Directors would like to communicate directly with you in the form of Newsletters, Notice of Board of Directors Meetings, Meeting Agendas, Architectural Request Forms and other official business via email. In order to initiate or decline this electronic delivery process, **you must return this signed statement of permission**, either via email to SHABoard@gmail.com, traditional mail to the P.O. Box listed above, or in person to the SHA Board drop box located on the shed in the pool/common area.

By signing this agreement, not only does **your association save costs associated with printing and mailing**, but you also have access to monthly recurring items in a more timely and efficient manner. **The email address you provide will only be used for Sunrise Homeowners Association purposes and will not be shared, sold or given to any third parties.**
