# Architectural Review Committee Violations

The first round of violation notices have gone out and will continue to go out throughout the month of September and into early October. If you get one, we encourage you to give us a call or dial into our upcoming board meeting on Oct. 1st. We are here to work with you, explain the process and answer any questions you might have.

Residents will have 30 days to correct any violation before a fine/penalty will be issued. Fines start at \$25 and rise each month to a maximum of \$100. Fines are cumulative until violation(s) is corrected.
